## ANNOUNCEMENT OF THE RESULTS OF THE POLL

Arising from Agenda Item No. 7 on the Notice convening the AGM on election of Directors in accordance with the Articles 42, 43 and 47(b) of the Company's Articles of Association to fill four vacancies which arose from retirement by rotation of three (3) directors and resignation of another director, the poll returned the following results at the close thereof:
